INTRODUCTION

British Columbia has been the gateway to the Pacific for hundreds of years. Records of trans-Pacific crossings date back to the 1700s. Indigenous or mixed-race inhabitants from the Pacific Northwest¹ traveled to Asia in the 1840s, and sailors from China and Japan landed in the Pacific Northwest from earliest times. Chinese settlers arrived in the 1850s and were among the original settlers in the unceded territories of the Coast Salish peoples. This research guide provides a brief overview of some of the trans-Pacific holdings of the BC Archives: holdings related to Asia-Pacific Coast relations including migration, immigration and settlement, travel records, transportation, trade and diplomacy.

This guide was produced with the assistance of TransPacific History students from the University of Victoria and their instructor John Price.

PUBLISHED SOURCES

The BC Archives has a significant collection of published material related to trans-Pacific history. It consists of books, pamphlets, journal articles and sometimes theses (which may also be treated as manuscripts—see note under Primary Sources below). These sources are useful in gaining an understanding of historical developments and overall context, as well as in providing leads to further material.

Search the <u>BC Archives Library</u> catalogue using keywords, subjects, names, authors, or titles that you have identified as being of interest to your research. Note that too broad or general a word (e.g., "pacific") can yield a large number of references, many of which will not be relevant for your purposes. It is a good idea to start with the most specific terms and broaden your search if necessary.

When looking for information about a particular cultural group, check under the name, e.g., "Sikh" or "East Indians", as well as any geographic locations particularly associated with the community. If you have found relevant citations, look at the subject headings for those references. They may be useful in looking for further material.

Doing a paper for school and have limited time? Look for a book, scholarly article, or thesis on your topic and check the bibliography, especially for journal articles and unpublished material.

¹ The "Pacific Northwest" is loosely defined as that area of North America bounded by the Pacific Ocean on the west and the Rocky Mountains on the east. The northern boundary may or may not include the Yukon and southeast Alaska and the southern boundary northern California. The term is now commonly used to refer to British Columbia, Washington State, and Oregon.

PRIMARY SOURCES

The majority of the holdings at the BC Archives are unpublished, textual records. They can be government or non-government (sometimes referred to as "private") records and can be typed as well as handwritten. They are primary sources which you will need to analyse and interpret in order to make them useful to your research.

Note: A number of theses have been catalogued as manuscripts, others as library material. Search both the <u>BC Archives Library</u> and <u>BC Archives Collection</u> if you are looking for a particular thesis.

SEARCH TIPS

There is both a card and an online catalogue for searching records:

- Textual records indexed online (<u>BC Archives Collection</u>) are catalogued as either a government record accession (GR) or a non-government record accession (MS). Many have finding aids attached to their catalogue webpages. Finding aids can be box lists, file lists, volume lists, microfilm reel lists or indexes and should be consulted to help identify specfic records.
- The pre-1974 ("Old MS") card catalogue card catalogue located within the BC Archives reference room uses alpha-numeric classifications (e.g., E/D/L58) and can be searched by subject, title, and creator. Some of these records have been described and can also be searched online using the <u>BC Archives Collection</u>.

When searching either <u>BC Archives Collection</u> or card catalogues, use a variety of keywords. Some terms used within the catalogues use older spellings or are words which are no longer in contemporary use. The catalogues, online descriptions, and finding aids may also contain words which are not considered appropriate now, but which may be useful as search terms. For example, in addition to standard terms such as "Chinese", "Japanese", or "Sikh", you should also check for references such as "Japs", "Hindus", "Hindoos", "East Indians" or "Orientals".

Be aware that the <u>BC Archives Collection Search</u> automatically treats multiple keywords as a phrase. Thus, if you wish to search for records relating to Chinese in Vancouver, use the word "and" between the search terms (i.e., "Chinese and Vancouver". This search will locate any catalogue entries or finding aids that contain both the terms "Chinese" and "Vancouver". The wild card symbol is ?, and it may be used effectively to search for both singular and plural terms. For example, using the keyword "Jap?" will locate catalogue and finding aid entries that include the words Jap, Japan, Japs, and Japanese.

When using the <u>BC Archives Collection Search</u>, it can also be useful to use the name of the record creator as the search term. This applies whether the creator is an individual or an organization.

Search results will be presented as a list of accessions which have matches to the keywords. Some of the accessions have an attached finding aid, which will provide further information about the accession, and provide microfilm reel numbers, box numbers or a file or item list. Use the finding aid to determine the call number (GR/MS-xxxx) and the number of the box or microfilm reel you need.

ACCESS RESTRICTIONS

The contents of some government records and private records will be restricted for a variety of reasons. For example, government records 100 years old or less are subject to the *Freedom of Information and Protection of Privacy Act* (BC). Check the Notes field of a series' description for access information.

In addition, many records are stored off-site and cannot be made immediately available.

Government records provide a wealth of information on living conditions, demographics, and state perceptions of trans-Pacific peoples as well as many other topics. Crime, Drugs, Prostitution, And Alcohol

The principal source of information about these topics will be court records, and records created by the Attorney General's office. Court records include civil and criminal case files, orders, and judgements. The records are arranged by registry (i.e., court district) and court level (i.e., Supreme or County) and some have nominal indexes. For example:

- <u>MS-1079</u> Memoirs / Robert Frost, ca. 1979 Includes reminiscences of life in China as a ship's officer and as cargo superintendent with Jardine Mathesons, *To Russia with love from the Persian Gulf*, and *My Affair with Kuan Yin: The memoirs of Robert Frost*.
- <u>MS-1201</u> Kwong Lee and Co., 1885 Contains statement of accounts and receipts for Kwong Lee and Company.
- <u>MS-1249</u> Malcolm McLeod family papers, 1821-1899 Includes documents pertaining to Ranald Macdonald, the first English teacher in Japan; correspondence with Macdonald; reminiscences and Japanese glossaries by Macdonald; and manuscripts by McLeod entitled *Japan, story of adventure of Ranald Macdonald*.
- <u>MS-1304</u> Harrison, Eli, 1852-1930. Victoria; Judge, 1886 Letter from Caspar Phair, Sheriff of Lillooet, to Mr. Justice Harrison regarding the sitting of County Court and the gold discoveries made by Chinese miners at Cayoosh Creek.
- <u>MS-1641</u> Macmillan Bloedel Limited. Alberni Pacific Division, 1930-1979 Includes a schedule showing wages paid to apprentices, equipment operators, laborers, tradesmen, etc. at the Alberni operations of Macmillan Bloedel and its predecessors, including wage scale surveys and nominal lists of Chinese, South-Asian, and Japanese employees at Great Central Sawmill.
- <u>MS-2056</u> [James Bissett] diaries, letters, and notes, 1854-1914 Includes diaries for travels from Lachine to Honolulu, to Victoria, journeys to Europe, travel from Montreal, and a journey to Japan and China.

- <u>MS-2107</u> Lee, Jack H. Victoria, 1957 Includes draft transfers, bank money orders, and receipts for money sent to family in China.
- <u>MS-2119</u> [Winifred Awmack] Papers relating to the Japanese relocation centre at Tashme, 1944-1983

Contains papers relating to the Japanese relocation centre at Tashme during WWII, letters from students taught at Tashme camp, and government documents regarding Japanese-Canadian deportation.

- <u>MS-2429</u> Cornish, Clive Grierson, 1908-. "Condition Yellow", ca. 1946 Typescript of *Condition Yellow*, an unpublished novel concerning the internment of Japanese Canadians during World War II.

PHOTOGRAPHS, PAINTINGS, AND PRINTS

Search the <u>BC Archives Collection</u> by keyword for photographs, paintings, drawings, and prints. Try variant names and spellings, truncation, and wild cards (e.g., chin?). Filter results by clicking on Advanced Search and selecting "graphic material" within the General Material Designation drop-down menu. Filter further by selecting "Yes" from the Digital Object Available drop-down menu or by entering a date range.

SOUND RECORDINGS

Sound recordings include oral histories as well as radio broadcasts. The following are only a sample of recordings likely to have relevance for trans-Pacific research.

Filter results by clicking on Advanced Search and selecting "Sound Recording" within the General Material Designation drop-down menu. Filter further by entering a date range.

View the Notes area of a catologue entry to determine available recording formats (e.g., reference cassette, digital copy, preservation compact disc). Digitized copies are not available online due to file-size limitations. Such recordings can be accessed within the BC Archives

Reference Room. Some recordings are held within cold storage for preservation purposes and are restricted.

- <u>GR-3376</u> Sound Heritage Series sound programs, 1976-1983 Comprises 20 documentary sound programs produced to accompany publications in the Sound Heritage Series, a historical quarterly published by the BC Archives. Also see Sound Heritage Series (<u>NW 902 S725</u>) and Sound Heritage: Voices from British Columbia (<u>NW 902</u> <u>S726</u>), available in the Archives Library.
- <u>GR-3377</u> Provincial Archives of British Columbia audio interviews, 1974-1992 Interviews conducted by staff members and research associates of the BC Archives, including with several Chinese and Japanese Canadians.
- <u>PR-1789</u> [Coal Tyee Society] history of coal mining collection, 1978-1984 Some of the interviews deal with the Japanese and Chinese workers who participated in the Vancouver Island mining industry.
- <u>PR-1858</u> Downtown Eastside Women's Centre oral history collection, 1979 Consists of oral history interviews with women who lived and worked in the downtown core of Vancouver, including a number of Chinese-Canadian women.
- <u>PR-1905</u> Strathcona Project collection, 1977-1978 Interviews by Daphne Marlatt and Carole Itter with residents of Vancouver's Strathcona neighbourhood, recorded for the book *Opening Doors in Vancouver's East End: Strathcona*, available in the Archives Library (<u>NW 971.133 O64 2011</u>).
- <u>PR-1993</u> Reynoldston Research and Studies oral history collection, 1972-1974 Includes oral history interviews with Japanese-Canadian and Ugandan-Canadian immigrants. Also see *Reynoldston Research and Studies Publication*, available in the Archives Library (<u>NW 902 R466p</u>) and <u>online</u>.

Selected oral history interviews:

• <u>AAAB0070</u> Kiyo Goto interview, 1972

Kiyo Goto was a Japanese 'picture bride' who came to Canada in 1915. She talks about her experience working as a housekeeper, then running a restaurant and brothel in Vancouver, and opening a gambling house while interned at Greenwood camp during the Second World War. Interview is conducted in Japanese.

- <u>AAAB0108</u> and <u>AAAB4829</u> Tatsuro 'Buck' Suzuki interviews, ca. 1972–1977 Tatsuro Suzuki (b. 1916) was a second generation Japanese-Canadian, who was prominent in the Japanese Fisherman's Union and the Japanese-Canadian Citizen's Association. He discusses the Japanese community in the twentieth century, including the fishing industry, Japanese rituals and festivals, race relations, the internment of Japanese Canadians, and the struggle for the enfranchisement of Japanese Canadians.
- <u>AAAB2606</u> Edward Banno interview, ca. 1976 Edward Banno was a member of a delegation of Japanese Canadians who traveled to Ottawa in 1936 to plead for the right to vote.
- <u>AAAB2995</u> Yun Ho Chang interview, 1977 Yun Ho Chang discusses the Chinese community within the Strathcona neighbourhood during the 1920s-1930s.
- <u>AAAB3439</u> Gordon (Won) Cumyow interview, 1977 Gordon (Won) Cumyow's grandfather ran a supply store for gold rush miners in Fort Douglas and later moved to New Westminster. His father was possibly the first Chinese Canadian born in Canada and was the first Chinese court interpreter. He also spoke Chinook.

• <u>AAAB4107</u> Koo Shee Chan interview, 1980

Koo Shee Chan immigrated to Canada in 1911 as a 'picture bride.' She talks about her experiences raising a family in Victoria, the Chinese Christian Church, indentured waitresses in restaurants in Chinatown, and the Oriental Girl's Mission. Interview was conducted in Chinese.

- <u>AAAB4128</u> Rev. Yee Jing Chow interviews, 1980 Rev. Yee Jing Chow (b. 1899) was a Chinese Christian Missionary who immigrated to British Columbia in 1912. He discusses Chinese communities in Nelson, Vancouver, and Victoria, and the Oriental Girl's Mission in Victoria. Interview was conducted in Chinese.
- <u>AAAB5328</u> Dick Mah interview, 1979
 Dick Mah discusses Vancouver Island's coal mining industry and mining communities, Bing Kee coal rights, origins of the Mah family, racial discrimination, the head tax, origins of Chinatown, opium, early cars, and electricity.

Radio Broadcasts

The BC Archives holds many sound recordings from private radio stations as well as the Canadian Broadcast Corporation (CBC). A number of CBC radio producers have also donated material, which may contain material relevant to trans-Pacific research.

Selected radio broadcast collections:

- <u>AAAB2801</u> Jurgen Hesse immigrant interviews, 1974-1975 Consists of short interviews with immigrants, who discuss their experiences and what Canada means to them.
- <u>PR-0374</u> Imbert Orchard Fonds, 1898-[1950s]; 1959-1985; predominant 1959-1979 Consists of oral history interviews, radio programs, and other sound recordings, as well as scripts, notes, correspondence, photographs, two amateur films, and a drawing created or accumulated during the production of interviews and documentary radio programs for the Canadian Broadcasting Corporation in Vancouver and as a university professor and freelance radio producer.
- <u>PR-2263</u> Robert Chesterman fonds, 1959-1987; predominant 1963-1987 Consists of 524 audio reels, the majority of which (484 reels) contain radio programs produced by Chesterman at CBC Vancouver.
- <u>PR-2257</u> Don Mowatt fonds, 1959 ; 1965-1987; predominantly 1965-1987 Includes concerts, documentaries, radio plays, most of the programs from the series "The Hornby Collection", several programs from "Testament", and many examples of his work for other series, including "Heritage Theatre", "The Bush and the Salon", "Ideas", "CBC Stage", and others.

Selected radio broadcasts:

- <u>AAAC2198</u> Hon. Lee Chow, 1945 Lee Chow was the Chinese Consul General in Vancouver. This a recording of his speech about the end of the Pacific War in 1945.
- <u>AAAC2084</u> Prime Minister Nehru in Vancouver, 1949 News coverage of the visit of Indian Prime Minister Jawharlal Nehru to Vancouver in 1949. Includes Hindustani language material.
- <u>T0327:0001 0002</u> H.H. Stevens interview, 15 Jul. 1966
 H.H. Stevens (1878 1973) was a B.C. Member of Parliament and cabinet minister between 1911 and 1940. He discusses his political career as well as his opposition to trans-Pacific immigration in B.C.
- <u>AAAB1482</u> Roy Mah interview, [1970?]

Roy Mah was director of the Vancouver Chinese Publicity Bureau and editor of the "Chinaman News." He talks about Chinese-white relations, Chinese education in Vancouver, and the race riots of 1907.

 <u>T1959:0001</u> Venture 64: The Komagata Maru affair, 1964 Radio documentary about the Komagata Maru incident in Vancouver Harbour in 1914.

Filter results by clicking on Advanced Search and selecting "Moving Images" within the General Material Designation drop-down menu. Filter further by entering a date range.

View the Notes area of a catologue entry to determine available recording formats (e.g., VHS reference copy, digital copy, preservation compact disc). Digitized copies are not available online due to file-size limitations. Such recordings can be viewed within the BC Archives Reference Room. Some recordings are held within cold storage for preservation purposes and cannot be accessed.

- <u>AAAA1119</u> Chinese theatre performance [Vancouver], 1944 Contains scenes from a Cantonese opera performance in Vancouver's Chinatown, filmed from a seat in the theatre auditorium.
- <u>V1991:01/0001.01</u> Chinese funeral parade, Victoria, 1918
- <u>AAAA3672</u> Heritage Buildings, Lai at Immigration Building, ca. 1977 Television stock footage, including tour of Immigration Building in Victoria by Dr. David Lai. He talks about Chinese immigration, the head tax, and transcribes Chinese writing on the walls of holding cells.
- <u>V2007:02/014</u> Where's Winston?, Mar. 1989 Instructional video loosely based on the real-life story of a Chinese-Canadian youth who became involved in criminal gang activities.

MAPS AND PLANS

Search the <u>BC Archives Collection</u> by keyword. Try variant names and spellings, truncation, and wild cards. Filter results by clicking on Advanced Search and selecting "Cartographic Material" within the General Material Designation drop-down menu. Filter further by selecting "Yes" from the Digital Object Available drop-down menu or by entering a date range.

Digitized copies are often not available online due to file-size limitations. They must be viewed on microfiche in the BC Archives Reference Room.

A large portion of the BC Archvies' maps and plans have not be catalogued online. They must be searched using the cartographic materials card catalogue the BC Archives Reference Room and then viewed on microfiche.

Newspapers can be a useful source of local information as well as a source for public response to events and issues. Many of them are also available online:

The BC Archives' vertical files (ca. 1930-1981) contain newspaper articles and other records about noteworthy individuals or subjects, arranged alphabetically. Files are available on microfilm in the BC Archives Reference Room. Search the *Vertical File Index* on our <u>Guides</u>, <u>Indexes</u>, and <u>Inventories webpage</u> for standard subject headings such as "Chinese", "Japanese", "Komagata Maru", "Vancouver Race Riots", or individual names.
